## **General entry rules & information**

### Submission cost?

• Submission and entry for the Real IT Awards is free.

#### Who can enter?

- ALL categories are open to organisations with turnover in excess of £150m or equivalent for public sector organisations.
- All Corporate IT Forum member organisations are eligible for entry regardless of the organisation's turnover.
- **Note to Suppliers:** Your submissions **must** be based on a partnership project carried out with a customer (i.e., a public or private organisation).

## **Submission details**

- All entered projects must be completed or have gone live between 1 November 2016 and 31 December 2017.
- The entry deadline is 02 February 2018.
- A single project may be entered for up to two award categories. Projects entered for more than one category must have separate Entry Forms.
- All entries will be considered in confidence. The Entry Form asks you to provide a separate 100 word short description that can be used publicly in Awards materials and promotions.
- If you're submitting the same project(s) into both 'Organisational' and 'Project/Innovation' categories, please complete all 'blue' and 'yellow' fields on the entry form.
- If submitting a project into two 'Organisational' Awards categories, please complete <u>all</u> 'blue' fields only.
- If submitting a project into two 'Project/Innovation' Awards categories, please complete <u>all</u> 'yellow' fields only.
- All entries must include full contact details for a nominated representative of the organisation, who may be asked to support their entries by supplying any additional information requested by the judges.
- Relevant evidence and its source should be provided and this can include printed documentation, videos and testimonials. If this information is not yet available, please demonstrate the governance processes put into place to collect it.
- The decision of the judges is final in all matters.

## **Judging process**

## **Our Guiding Principles**

We select and invite individuals who have distinguished themselves in their field and demonstrated leadership ability and vision to be part of the judging panel. We hold our judges to the highest standards of fairness, accuracy and integrity. The entire judging process adheres firmly to these guiding principles.

## **Ensuring Impartiality**

We make all efforts to avoid conflicts of interest in the judging process (such as inadvertently assigning a judge to evaluate an entry with which he/she is associated). At least three judges are assigned to each entry at random from within the pool of judges whose expertise is relevant. All judges are screened before being assigned an entry. All of the judges are expected to and will excuse themselves from judging an entry that may present a conflict of interest.

### **Equal Treatment of All Entries**

Judges evaluate every entry with a discerning eye towards project scope and strategic goals. A professional execution under a limited budget is more worthy than a mediocre execution for a well-funded initiative. It is execution that matters not total project scope.

## The Judging System

To evaluate entries judges utilise a points-based scoring system which allows each entry to receive a maximum of 110 points. Points have been split between five different components with two specific attributes that the submission will be scored against. Each judge will score each submission within their designated category, scores will then be combined to identify the shortlist/winner. For further information please refer to the judging criteria below.

By adhering to the specific guidelines and criteria of this system judges are able to maintain the highest degree of fairness, accuracy and integrity; competently and effectively evaluate entries; and, deliver clear results. It is possible that more than one entry may qualify to win the same category.

Each category winner is scored again by the panel judges against the judging criteria to select the overall winner.

Decisions made by judges are final. The judges' decisions cannot be appealed.

## **Shortlists**

After the entry deadline on 02 February 2018, each submission is checked to ensure compliance with our entry requirements. Then, for each of the 20 award categories, entries are shortlisted by our judges, scoring each entry against the judging criteria.

## **Judging criteria**

Our judges evaluate entries across all categories based on following components and attributes:

## Award categories

# Only organisations with turnover in excess of £150m or equivalent may enter

## **ORGANISATIONAL AWARDS**

#### 1. Technology Partnership of the Year

Awarded to Technology teams that demonstrate how to build & maintain effective partnerships with either single or multiple suppliers. Submissions should demonstrate how the partnership has delivered and sustained success over time and has specifically met and exceeded business expectations. Entrants need to describe how the partnership has been successfully managed, for example, establishing clearly-defined governance or showing how they identified where value is not being realised and the appropriate actions taken. Collaborative management/governance and leadership should be clearly represented.

#### 2. Technology Team of the Year

The award will recognise a multi-functional team that has been established for the delivery of a product/project that can demonstrate how they have worked collaboratively to bring tangible benefits to their business through its successful planning, clear communication, strong commitment and leadership in their day-to-day operation. This category acknowledges teams that drive best practice through governance frameworks, stakeholder engagement process, change management and cultural changes.

#### 3. Technology Product/Project Team of the Year

This award recognises a Technology project team that worked collaboratively to design, develop, implement and measure the benefits of a business project and achieved its goal through its successful planning, clear communication, strong commitment and leadership throughout the life of the project. Entrants need to demonstrate how they driven best practices through governance frameworks, stakeholder engagement process, performance management and cultural changes.

#### 4. Best Place to Work in Digital

This award recognises an organisation that has made significant progress in attracting and retaining the best talent to support the Digital Enterprise through diversity, gender balance, apprentice/graduate schemes and other initiatives that make it a great place to work.

#### 5. Technology Development Programme of the Year

This award recognises an Organisation that has put in place an effective development programme to promote a culture of continuous learning within their organisation. This could be an Apprenticeship or Graduate Scheme, promotion of soft-skill development for their employees or a variety of different approaches which have increased the overall skills and capabilities of the team.

#### 6. Services Company of the Year

Awarded to recognise excellence in the provision of Technology Services. This category recognises a supplier of hardware, software and/or Technology services that has achieved significant business success in the past 12 months and can demonstrate high levels of customer satisfaction and business benefits from the users of its products and services.

## **PROJECT AWARDS**

#### 7. Project of the Year (total budget > £250K)

This category recognises outstanding projects/products that have transformed how their organisations do business using Digital technologies, delivering increased revenue, brand recognition or other business benefits. Judges will be looking for innovative approaches or ideas and smart ways of integrating into legacy/heritage backend systems. For this category the total spend for the project/product is over £250K

#### 8. Project of the Year (total budget up to £250K)

This category recognises outstanding projects/products that have transformed how their organisations do business using Digital technologies, delivering increased revenue, brand recognition or other business benefits. Judges will be looking for innovative approaches or ideas and smart ways of integrating into legacy/heritage backend systems. For this category the total spend for the project/product is up to £250K

#### 9. Mobile App of the Year

Awarded to mobile apps that run on mobile phones, tablets or other devices with built-in 3G or 4G capability. These apps should show an innovative use of the technology on the device, and possibly of on-line services.

#### 10. Agile Project of the Year

This category recognises outstanding products/projects that have been delivered using Agile Methodologies and have in turn delivered rapid business capabilities that have allowed their businesses to change their ways of working or route to market. Judges will be looking for approaches that have led to early releases of capability and business benefit

#### **11. Operational Efficiency**

This category honours the delivery of simplification, higher productivity or improved process speed. Entrants need to show that they found the optimum balance between cost and quality and have utilised technology and business processes in the best possible way.

#### 12. Cloud Project

This award recognises Technology teams that have effectively selected, implemented and managed a cloud solution that focused on business objectives. Solutions could include IaaS, PaaS or SaaS, Private Cloud, Public Cloud or Virtual Private Cloud. Entrants need to illustrate systematic transformation of the appropriate application and/or infrastructure components measured by clear quantifiable benefits.

#### **13. Service Improvement**

This category recognises Technology teams that have driven improvement in business operation and/or customer experience using their knowledge, insight and understanding of how Technology services contribute to the Business. Entrants need to demonstrate they have improved quality of service to external/internal customers by offering greater capability or choice.

#### 14. Turning Data into Insights

Honouring Technology products/projects that illustrate the most effective use of previously unharnessed or new or complex sources or data within Big Data, Social media analytics, advanced predictive analytics and prescriptive analysis, and in-memory analytics. This category seeks to identify a project that demonstrates innovative use of data, tools and business knowledge to produce information that is of value to the business as a whole, enabling business leaders to evaluate the economical implications of actions, increase understanding of customer trends and identify high value actions.

## **INNOVATION AWARDS**

#### 15. Innovation in Technology

This award recognises delivery of clear pioneering and transformative technology, such as IoT or Data Science etc., showcasing what IT has done to advance the potential of applications and/or technology so that they can be used to drive better efficiency and productivity as well as the outcomes and performance of an organisation. Technology teams need to demonstrate they have recognised innovations that are driven either externally or internally by R&D. Products/Projects should clearly demonstrate specific business impact.

#### 16. Collaborative Enterprise

This award recognises projects that have demonstrated an effective delivery of collaborative technologies (inter department or inter business location or group), for example, to support intelligence gathering, knowledge sharing, learning or training. Technology teams need to demonstrate how technology helps underpin knowledge workers' effectiveness and expertise by creating a more flexible and manageable environment. The approach should foster not only innovation and agility but also efficiency and scalability and 'cross-fertilisation' of ideas.

#### 17. Infrastructure as an Enabler

Awarded to Technology teams that demonstrate high effectiveness in handling future infrastructure needs in Technology and/or the business, at optimal cost and with minimal impact on BAU to support the Business in its requirements or desire for innovative change. The project should enable the Business to function successfully (from a technology perspective) for a reasonable period to come whilst delivering clear Business benefit. Projects could be anything from Data Centre/Server rationalisation or IaaS deployment to end user device deployment.

#### 18. Game Changer of the Year

This award recognises Technology Teams that have initiated/supported the delivery of innovative working practices to the Business that changes the way it operates. Technology teams need to demonstrate that they have actively responded to business needs by offering solutions or services that have helped to drive change in the Business supported by proven technology.

#### 19. Innovation in Cyber Security & Compliance

This award recognises innovative approaches in the area of Cyber Security or Compliance. This could include development of a Security Awareness Programme, a robust approach to preparation for GDPR, innovative ways your security function offered value to your business in order to be seen as an enabler rather than a blocker or developing creative ways to improve controls across the business.

#### 20. Best Use of Emerging/New Technology

This award will recognise an organisation where Emerging/New Technologies have been successfully deployed to meet a business need. This could include Machine Learning, IoT or other growing/upcoming technologies. It may well have been developed in conjunction with a trusted vendor.

#### 21. Special Achievement

This award will be given in recognition of outstanding contribution to The Corporate IT Forum. There will be no submissions by entrants for the category.
